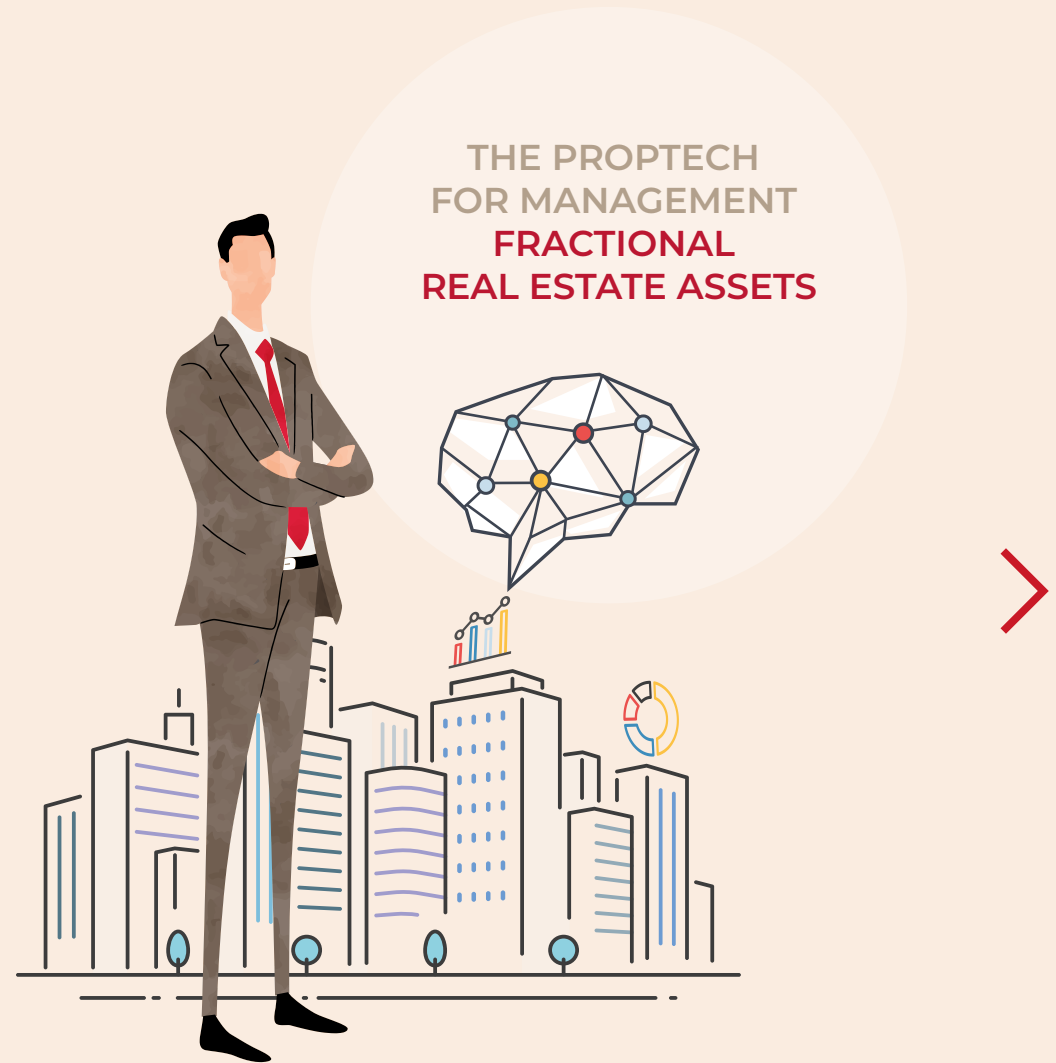

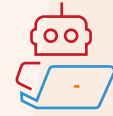

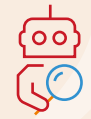

EASYRE also offers **support for campaign planning on real estate portals**, suggesting timing and publication methods that guarantee better results



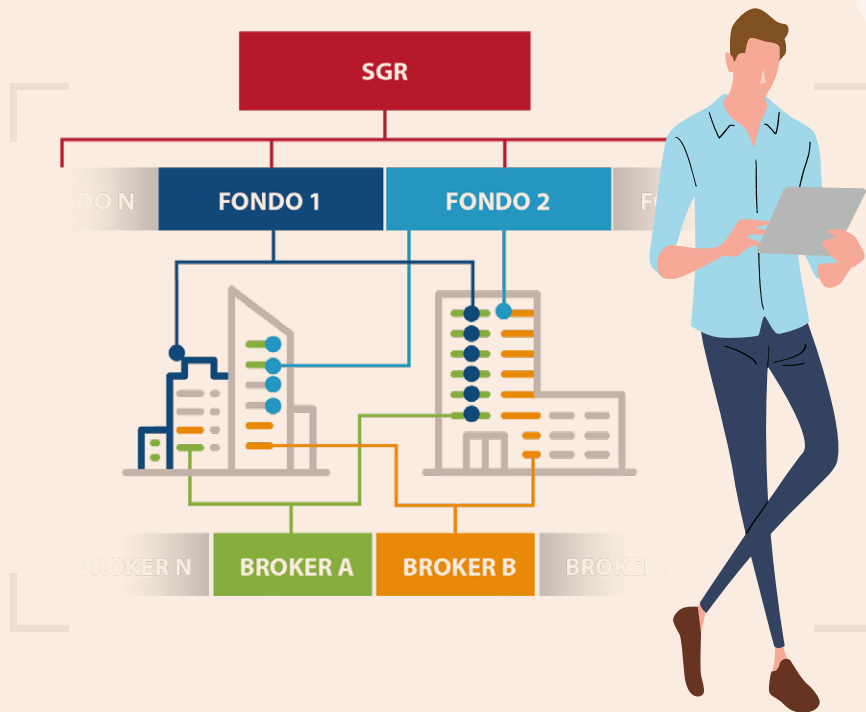

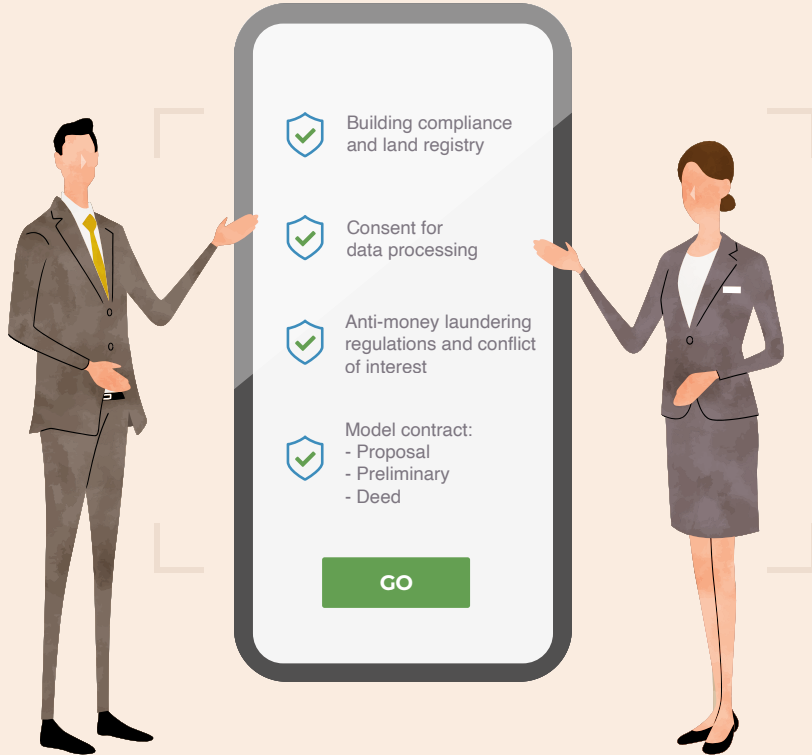
Transforms your business into an efficient machine
